ORDER:-

In the order first read above, the National Green Tribunal (Southern Zone) has directed *inter-alia* as follows:-

"The Chief Secretary is directed to form a permanent committee consisting of the Additional Chief Secretary for Environment, Forests and Climate Change, Director, Geology and Mining Department, the Member Secretary of Coastal Zone Management Authority, the District Collector, Chennai and Commissioner of Police or his nominee not below the rank of Joint Commissioner in the Committee to monitor the sensitive areas where such alleged illegal activities are said to be happening and take appropriate action against those violators."

2. In the letter second read above, the Member Secretary, Tamil Nadu State Coastal Zone Management Authority / Director, Department of Environment and Climate Change has requested to issue further orders or directions on this issue.

3. After examination, the Government hereby constitutes a permanent committee for monitoring the sensitive areas where such alleged illegal activities are said to be happening and for taking appropriate action against those violators comprising with the following members:-

(i)	Additional Chief Secretary/ Principal Secretary/ Secretary to Government, Environment, Climate Change and Forest Department.	Chairperson
(ii)	Commissioner of Police or his nominee not below the rank of Joint Commissioner	Member
(iii)	The Director, Geology and Mining Department	Member
(iv)	The District Collector, Chennai	Member
(v)	The Member Secretary, Tamil Nadu State Coastal Zone Management Authority / Director, Department of Environment and Climate Change.
