ORDER:-

In the letter first read above, the Government have permitted the Director of Environment, to pay the sitting fee for the non-official members of the Tamil Nadu State Coastal Zone Management Authority (TNSCZMA) as per the G.O.(Ms) No.348, Finance (BPE) Department, dated 16.12.2011 and to meet the expenditure therefor from the State Coastal Management Fund. Based on the above said Government Order, the sitting fee of Rs.2000/- per sitting to the Expert Members of the Tamil Nadu State Coastal Zone Management Authority is being paid, till date.

2. In the letter third read above, the Member Secretary, Tamil Nadu State Coastal Zone Management Authority has stated that in the 110th meeting of the Tamil Nadu State Coastal Zone Management Authority (TNSCZMA) held on 28.10.2020, Tamil Nadu State Coastal Zone Management Authority has resolved to revise the Sitting fees offered to the members of the Authority, on par with the Members of the State Expert Appraisal Committee (SEAC) /State Level Environment Impact Assessment Authority (SEIAA). As per the second Government Order read above, the Government have issued orders to enhance the sitting

fees for the members of the State Level Appraisal Committee (SEAC) to Rs.7000/- per sitting.

3. The Member Secretary, Tamil Nadu State Coastal Zone Management Authority / Director, Department of Environment has requested to enhance the sitting fee to the Expert Members of the Tamil Nadu State Coastal Zone Management Authority from Rs.2000/- to Rs.7000/-, on par with the members of the State Expert Appraisal Committee (SEAC) and the expenditure will be incurred from the State Coastal Zone Development Fund.

4. After careful examination, the Government have accepted the proposal of Member Secretary, Tamil Nadu State Coastal Zone Management Authority and enhance the sitting fees for the Expert members (non-Official members) from Rs.2000/- to Rs.7,000/- on par with the Members of State Expert Appraisal Committee (SEAC).
