#### ORDER:-

In the Government order first read above, the Government have accorded administrative sanction for 10 beaches to be taken up under the Beach Environment and Aesthetic Management System (BEAMS) programme in the next 5 years at a total cost of Rs.100 crore with funding support from Tamil Nadu Pollution Control Board/Ministry of Environment, Forest and Climate Change/ Society of Integrated Coastal Management (SICOM)/ Department of Environment etc.,

- 2. Based on the request of the Department of Environment and Climate Change, the Government constituted the expert Committee for the selection of single source method in the provision of TNTT Act, 1998. As recommended by the Expert Committee, the National Centre for Sustainable Coastal Management, has been entrusted to prepare the DPR for 10 beaches under Blue Flag Certification Programme in Tamil Nadu, vide Government order second read above.
- 3. The Director, Department of Environment and Climate Change has requested the Government to issue orders for permitting the Department of Environment and Climate Change to carryout the baseline survey for the Blue Flag Beach through National Centre for Sustainable Coastal Management, at a cost of

Rs.1,27,44,000/- (Rupee One Crore Twenty Seven Lakh Forty Four Thousand only, inclusive of GST) from State Coastal Zone Development Fund (SCZDF).

- 4. After careful examination, the Government has decided to accept the proposal of the Director, Department of Environment and Climate Change and permit him to carryout the baseline survey for the Blue Flag Beach through NCSCM at a cost of Rs.1,27,44,000/- (Rupee One Crore Twenty Seven Lakh Forty Four Thousand only, inclusive of GST) from "State Coastal Zone Development Fund (SCZDF)".
- 5. This order issues with the concurrence of Finance Department vide its U.O. No.51629/Finance (E,CC&F) Department/22, dated 30.11.2022.
