ORDER:

In the Government Order first read above, the Government accorded administrative sanction for a sum of Rs.1481.80 crore to implement the Coastal Disaster Risk Reduction Project by the Implementation agencies under the overall control and supervision of the Coastal Disaster Risk Reduction Project Management Unit. The project also includes a sum of Rs.7.50 crore allocated to the Director of Environment for completing the balance works by Department of Environment under CDRRP under Component-3 Capacity Building in Disaster Risk Management -Sub Component 3.4 -Integrated Coastal Zone Management Plan. The Department of

Environment have completed all the works at a cost of Rs.4.51 crore and a balance funds of Rs.2.99 crore is, left as savings.

2. In the Government Order third read above, Government accorded approval for the preparation of Local Level ICZMP mapping in 1:5000 scale at a cost of Rs.2,72,04,860/- from the savings amount of Rs.2.99 crore available with Department of Environment under ICZMP component of CDRRP and also entrust the work to IRS, Anna University and to sanction certain staffs to Environment Department for coordination and technical support for the above scheme and to meet the expenditure on salary of the staff to be met out from balance amount available under this sub-component.

3. In the letter fourth read above, the Director of Environment addressed the Commissioner, Disaster Management, Tamil Nadu State Disaster Management Agency and requested to release the above said amount to the Department of Environment , so as to complete the preparation of Local Level ICZMP maps under CDRRP effectively, within a stipulated time.

4. In the letter fifth read above, the Commissioner, Disaster Management enclosed a copy of the letter received from Director of Environment and requested the Government to release the above said amount to Director of Environment so as to complete the preparation of local level ICZMP under CDRRP effectively within a stipulated time.

5. In the Government Order sixth read above, the Government accorded sanction for a sum of Rs.27.60 lakhs alone towards the preparation of Local Level Integrated Coastal Zone Management Plan mapping in 1:5000 scale from the savings amount of Rs.2.99 crore available with the Department of Environment under Integrated Coastal Zone Management Plane component of Coastal Disaster Risk Reduction Project.

6. In the letter seventh read above, the Commissioner, Disaster Management has requested to issue necessary amendment to G.O (Ms) No. 77, Revenue and D.M [D.M4(1)] Department, dated:23.02.2018 and to authorise the Director of Environment to draw the amount of Rs.2.99 crore for which administrative sanction has been ordered in the G.O (Ms) No. 306, Revenue and D.M [D.M4(1)] Department, dated: 21.09.2017.

7. The request of the Commissioner, Disaster Management to accord financial sanction for a sum of Rs.2,72,04,860 from the allocated amount of Rs.2.99 crore for the preparation of local level ICZMP Mapping in 1:5000 scale under local level ICZMP component of CDRRP, and to incur the expenditure towards salary for the staff sanctioned at para 5 in G.O(Ms) No.306, Revenue and Disaster Management [D.M4(1)]

Department dated:21.09.2017 through outsourcing to Environment Department for coordination and technical support for the above scheme which has been worked out to Rs.27.60 lakhs from the balance amount available in this sub-component has been examined in detail.

8. The Government after careful examination, accord financial sanction for a sum of Rs.2.9965 crore (Rupees Two crore and ninety nine lakhs sixty five thousand only) towards preparation of Local Level Integrated Coastal Zone Management Plan mapping in 1:5000 Scale under Integrated Coastal Zone Managements Plan Component of Coastal Disaster Risk Reduction Project as ordered in the Government order third and sixth read above as detailed below:-

i) Preparation of local level ICZMP Mapping in 1:5000 scale :	Rs. 2,72,04,860/-
ii) Engage Staff through out sourcing	Rs. <u>27,60,000/-</u>
Total	<u>Rs.2,99,64,860/-</u>

9. The amount sanctioned in paragraph 8 above shall be debited to the following head of account:-

3435 - Ecology and Environment -03- Environment Research and Ecological Regeneration -102 Environmental Planning and co-ordination – Externally Aided Project – QA-World bank assisted Emergency Tsunami Reconstruction Project – (ETRP) - Environment – 333 - Payments for professional and special service - 09 - other payments.

10. Necessary additional funds of Rs.2.9965 crore will be provided in FMA 2019-2020. Pending provision of funds in FMA-2019-2020, the Principal Secretary and Commissioner of Revenue Administration is authorized to draw and utilize the amount sanctioned in para 8 above. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2019-2020. The Principal Secretary and Commissioner of Revenue Administration is directed to include this item of expenditure while sending the proposal for RE/FMA 2019-2020 and also send draft explanatory note for inclusion of the expenditure in the Supplementary Estimate to Government in Finance (AHD&F) Department without fail.

11. The Director of Environment is authorized to draw the amount sanctioned in paragraph 8 above and requested to send a Statement of Expenditure Utilization certificate and the progress report to the Project Director, Coastal Disaster Risk Reduction Project (CDRRP), Government and the Accountant General in due course.
