AGENDA ITEM NO.01: Confirmation of the minutes of the 51st meeting of

The 51sr meeting of the Tamil Nadu State Coastal Zone Management Authority was held on 06.05.2009 and the minutes were communicated in letter no.P1/1578/2005 dated 18.05.2009 of Director of Environment. It may be confirmed.

AGENDA ITEM NO.1 Confirmation of the Minutes of the 50th meeting of the State Coastal Zone Management Authority held on 06.03.2009.

The minutes of the 50th meeting of the Tamil Nadu State Coastal Zone Management Authority held on 06.03.2009 communicated in Letter No.P1/1578/2005 dated 03.04.2009 of the Director of Environment was confirmed.

AGENDA ITEM NO.2 Report on the follow up action taken in respect of decisions taken during the 50th meeting of the SCZMA.

The Member Secretary briefed the members about the action taken on the decisions taken during the 50th meeting of the State Coastal Zone Management authority held on 06.03.2009.

AGENDA ITEM NO.3 Housing reconstruction in CRZ areas between 200 mts and 500 mts at 11 habitations in Ramanathapuram District under ETRP (Emergency Tsunami reconstruction Programme)

The Authority resolved to clear the proposals subject to the following specific conditions:

- a) All activities should be in conformity with the provisions of the CRZ Notification 1991.
- b) The activities should not cause any adverse impact on the nearby ecological bio-diversities
- c) There should not be any ground water extraction in CRZ
- d) Treated/untreated sewage should not be let out in the CRZ
- e) Water and sanitation conditions may be taken due care by providing proper treatment system.

- f) Natural landforms in the coastal zone like beaches and dunes should not be altered or levelled.
- g) Debris strewn in backwater areas should be removed.
- h) Proper arrangements should be made for the proper disposal of solid wastes generated in the project areas.

AGENDA ITEM NO:4 Construction of BSNL Administrative Office building at R.S. No. 799 part of Meelavittan village, Thoothukkudi taluk, Thoothukkudi district

The Authority resolved to clear the project subject to the following specific conditions:

- a) No drawal of ground water in CRZ area
- b) Planning permission should be obtained from the Department of Town and Country Planning as per Town and Country Planning regulations prior to the commencement of constructions. The constructions should be carried out as per the existing norms of FSI/FAR approved by the Department of Town and Country Planning.
- c) Strict adherence of provisions of CRZ Notification 1991

<u>AGENDA ITEM NO:5</u> Construction of a beach resort at Kilputhupet village, Tindivanam taluk, Villupuram district proposed by M/s. Bonjour Bonheur Oceann Spraay.

The Authority resolved to recommend this proposal to Government of India for consideration subject to the following specific conditions:

- a) Planning permission should be obtained for their constructions in CRZ from the DTCP.
- b) No ground water extraction in CRZ areas.
- c) Should adopt techniques for maximum Rain Water Harvesting.
- d) The applicant should obtain NOC for the drawal of ground water in that locality from the Ground Water Board.

- e) Zero discharge concept should be adopted for sewerage disposal.
- f) Clearance should be obtained from the Tamil Nadu Pollution Control

 Board under Air and Water Acts
- g) Strict adherence of provisions of CRZ Notification 1991.
 Further, the Authority resolved to request the Tamil Nadu Pollution
 Control Board to monitor the adherence of above stipulated conditions.

AGENDA ITEM NO:6 Construction of a Resort at S.Nos. 98/5B1, 98/5B2, 98/6A, 98/6B, 98/9A, 98/9B, 98/7 of Muthukadu Village, Chengalpattu taluk, Kancheepuram district by M/s. Kaiser Surya Samudra Resorts Pvt. Ltd., Chennai

- a) Water requirement should not be met from the existing dug wells in the project areas as the entire project area falling with in 500mts from the HTL of sea. As such the Authority resolved to request the applicant to create source of water from outside CRZ and to intimate the details of the same to the Authority for taking further action on the proposals.
- b) Further, the Authority resolved to authorize the Member Secretary, Tamil Nadu State Coastal Zone Management Authority to demarcate the presence of Sand dunes in the project area so as to prevent defacing of sand dunes in future.

AGENDA ITEM NO:7 Construction of IT Park in S.No. 281/2A1, 6A, 2B1B AND 6B of Kottivakkam village, Old Mahapalipuram road, Kancheepuram district proposed by M/s. True Value Homes Private Limited

The Authority resolved to conduct the HTL survey along with a study for finding out the presence of salinity level, as per CRZ Notification 1991, in the Buckingham canal from Adyar to Muttukadu instead of taking decisions on selected project sites. The Authority resolved to authorize the Member Secretary, Tamil Nadu State Coastal Zone Management Authority (TNSCZMA) to conduct the above Survey by engaging Institute of Remote Sensing, Anna

University, an authorized agency approved by GoI. The Authority also authorized the Member Secretary, (TNSCZMA) to send appropriate proposals to GoI for excluding the Non-tidal areas from the Approved Coastal Zone Management Plan based on the findings.

<u>ADDITIONAL AGENDA ITEM NO:1</u> Status of property based on the HTL demarcation and salinity concentration

Whenever, if there is any dispute between the Approved Coastal Zone Management Plan and the HTL demarcation maps issued by the Authorized agencies, the Authority resolved to take decisions based on the actual ground realities/measurements from the HTL as instructed in Ir No. J-17011/16/93-IA-III dated 27th September 1996 of Ministry of Environment and Forests, Government of India.

<u>ADDITIONAL AGENDA ITEM NO:2</u> Celebration of International Day for Biological Diversity

The Authority resolved to permit the Member Secretary, SCZMA & Director of Environment to organize a seminar on BIODIVERSITY AND INVASIVE ALIEN SPECIES at a cost of Rs.2,50,000/- (Rupees Two Lakhs Fifty Thousands only) and the Authority authorized Director of Environment to meet out the expenditures from the State Coastal Zone Development fund. Seminar will be conducted through EMAT (Environment Management Agency of Tamil Nadu).

The Ministry of Environment and Forests, Government of India had clarified in letter no. J-17011/23/2000-IA-III dated 29.09.2000, "provisions of CRZ Notification, 1991 do not apply in the development of the plots outside of CRZ and henceforth such matter may be dealt at the State level itself.

AGENDA ITEM NO:06. Construction of Elevated Express Way from Chennai Port to Madhuravoyal proposed by M/s. Chennai Port Trust

M/s. Chennai Port Trust has proposed to construct Elevated Express Way from Chennai Port Gate No.10 to Madhuravoyal NH 4 along the Cooum river. The Project area falls in CRZ-I (ii) (LTL to HTL) and CRZ-II.

The subject was placed before the 49th meeting of the State Coastal Zone Management Authority (SCZMA) held on 12.01.2009 and the Authority has resolved to recommend the proposal to Ministry of Environment and Forests, Government of India subject to the following conditions.

- 1) The proposed constructions should not be in the inter-tidal zone (between LTL and HTL) and should be beyond HTL on the land ward side of the Cooum river.
- 2) The constructions should be located in such a way that they should not affect the hydraulic free flow of water in the Cooum river.
- 3) There should not be any extraction of ground water in CRZ.
- 4) No blasting activities in CRZ is permissible.

Accordingly proposals have been sent to National Coastal Zone Management Authority, Ministry of Environment and Forests, Government of India for clearance under CRZ Notification 1991.

However, as the part of the road is falling between HTL and LTL., the Ministry of Environment and Forests Department, GoI have instructed M/s. Chennai Port Trust to revise and submit the proposal as per the recommendations of SCZMA in letter F.No. 11-23/2009 -IA-III dated 09.06.2009.

In this connection the Chairman, Chennai Port Trust has informed in his letter dated 29.06.2009 that the realignment of the express way towards landward side of the HTL will cause a significant interference with the existing road systems and also built up structures thereby escalating cost of the Land Acquisition for the project and substantial cost and time overrun. He further indicated that the Elevated Corridor will run at a height of 7 mts above the level of the existing banks of the Cooum river and will be constructed on pillars which occupy comparatively less space on the banks and hence the environmental impact due to construction of the Elevated road on pillars in the inter tidal zone is not comparable to that of construction at the ground level. The Principal Secretary to Government, Highways and Minor Ports Department has also informed that the re-alignment of the road proposed for the express way to comply with the conditions imposed by the SCZMA means that considerable extent of land would have to be acquired for a substantial length and this will not only increase the cost of the project but will also delay its implementation due to land acquisition problems.

Hence the Chennai Port Trust has requested to reconsider the decision of the Authority (Condition Number 1) as the project is crucial to the development of Chennai Port as a major international hub for containers.

Construction of IT Park in S.No. 281/2A1, 6A, 2B1B AND 6B of Kottivakkam village, Old Mahapalipuram road, Kancheepuram district proposed by M/s. True Value Homes Private Limited.

A proposal for the construction of an IT park in S.No. 281/2A1, 6A, 2B1B and 6B of Kottivakkam village, Old Mahabalipuram Road, Tambaram Taluk, Kancheepuram District has been received from Ms. True Value Homes India Private Limited, Chennai for consideration. As recommended by the Authority the proposal was forwarded to MoEF., GoI. Government of India and MoEF issued Environmental Clearance in Ir. No. 21-333/2007 iA-III dated 29.02.2008 subject to the condition that "the proposed development shall be as per the approved CZMP of Tamil Nadu and the constructions shall be with FSI as existed on 19.02.1991".

In the references dated 22.12.2008 and 05.02.2009 M/s. TVH India Pvt. Ltd., has informed that the Buckingham canal along the project site has no tidal influence as per the map furnished by an authorized agency and hence requested to declare that their site is falling outside CRZ and the applicant also requested SCZMA to intimate the fact to MOEF., GoI so as to waive the floor space condition indicated above.

The subject has been placed before the 51st meeting conducted on 06.05.2009. The Authority resolved to conduct the HTL survey along with a study for finding out the presence of salinity level, as per CRZ Notification 1991, in the Buckingham canal from Adyar to Muttukadu instead of taking decisions on selected project sites. The Authority resolved to authorize the Member Secretary, Tamil Nadu State Coastal Zone Management Authority (TNSCZMA) to conduct the above Survey by engaging Institute of Remote Sensing, Anna University, an authorized agency approved by GoI. The Authority also authorized the Member Secretary, (TNSCZMA) to send appropriate proposals to GoI for excluding the Non-tidal areas from the Approved Coastal Zone Management Plan based on the findings.

Construction of a Resort at S.Nos. 98/5B1, 98/5B2, 98/6A, 98/6B, 98/9A, 98/9B, 98/7 of Muthukadu Village, Chengalpattu taluk, Kancheepuram district by M/s. Kaiser Surya Samudra Resorts Pvt. Ltd., Chennai

M/s. Kaiser Surya Samudra Resorts Pvt. Ltd., Chennai has submitted a proposal for the construction of a resort at 98/5B1, 98/5B2, 98/6A, 98/6B, 98/9A, 98/9B, 98/7 of Muthukadu Village, Chengalpattu taluk, Kancheepuram district. The applicant proposed to construct 91 guest rooms (Ground floor 42 rooms and first floor 49 rooms), restaurant, conference hall etc., in 4.62 Ha. The site falling in CRZ III.

The subject was placed before the Authority for consideration in the 50^{th} and 51^{st} meetings held on 06.03.2009 and 06.05.2009. In the last meeting the Authority has resolved to request the applicant to create source of water from outside CRZ and to intimate the details of the same to the Authority for taking further action on the proposals.

Accordingly the applicant in their letter dated 05.06.2009 submitted the following details/documents.

- i) that they proposed to purchase water from M/s. Imperial Granites (P) Ltd., Chennai and submit a copy of agreement entered with them.
- ii) M/s. Imperial Granites (P) Ltd., has proposed to draw water from their land falls in S.No.32/2B! of Kanathur Reddikuppam village of Kancheepuram district and the site falls 500mts away from the CRZ.
- iii) M/s. Imperial Granites (P) Ltd., has applied on 02.06.2009 to the Regional Ground Water Board, Chennai to accord permission for the drawal of ground water in the above said site and the applicant produced a copy of the said application dated 02.06.2009.

AGENDA ITEM NO.1 Confirmation of the Minutes of the 51st meeting of the State Coastal Zone Management Authority held on 06.05.2009.

The minutes of the 51st meeting of the Tamil Nadu State Coastal Zone Management Authority held on 06.05.2009 communicated in Letter No.P1/1578/2005 dated 18.05.2009 of the Director of Environment was confirmed.

AGENDA ITEM NO.2 Report on the follow up action taken in respect of decisions taken during the 51st meeting of the SCZMA.

The Member Secretary briefed the members about the action taken on the decisions taken during the 51^{st} meeting of the State Coastal Zone Management authority held on 06.05.2009.

AGENDA ITEM NO.3 Re-Construction of houses under ETRP (VRCC) HOUSING PROJECTS between 200mts and 500mts from HTL in CRZ III.

The Authority resolved to clear the proposals subject to the following specific conditions:

- a) All activities should be in conformity with the provisions of the CRZ Notification 1991.
- b) The activities should not cause any adverse impact on the nearby ecological bio-diversity.
- c) There should not be any ground water extraction in CRZ
- d) Treated/untreated sewage should not be let out in the CRZ
- e) Water and sanitation conditions may be taken due care by providing proper treatment system.
- f) Natural landforms in the coastal zone like beaches and dunes should not be altered or levelled.

- g) Debris strewn in backwater areas should be removed.
- h) Proper arrangements should be made for the proper disposal of solid wastes generated in the project areas.

AGENDA ITEM NO:4

Reconstruction of buildings/sheds of existing Steel Manufacturing unit at Tiruvottiyur, Tiruvallur district proposed by M/s. Shree Ganesh Steel Rolling Mills Ltd., Chennai.

As the unit is producing 50 MT of TMT Bars per day from 1986 onwards and the unit has informed that their final product is only 50 MT per day, the Authority after detailed discussions opined that their activity is not construed as Expansion of activities as there is no capacity addition or addition in terms of production. The unit has obtained Planning Permission for their original constructions from the local body during 1974 and constructed the buildings / sheds without obtaining Planning Permission from the CMDA. In this connection the Authority has opined that construction of buildings is permissible as per CRZ Notification 1991 as the unit is situated in CRZ II on the landward side of the existing Ennore High Way.

In view of above facts, the Authority resolved to direct the applicant to approach the CMDA and obtain planning permission for all their constructions immediately.

AGENDA ITEM NO:5

Construction of Commercial cum Hotel Building at 110, Old Mahabalipuram road, Thiruvanmiyur village, Chennai 600 041 proposed by M/s. Brigade Enterprises Limited.

The Chennai Corporation has issued a certificate stating that the Perun Thalaivar Kamarajar Street (PTK Nagar street) of 20' wide was laid and being maintained by the Corporation of Chennai and the CMDA has also approved a layout based on the said road during 1992. Hence the Authority accepted the availability of a road in between the site and the Buckingham road during 1991.

Further the unit has informed that there is no tidal influence along the Buckingham canal behind the project site as per the HTL demarcation survey conducted by the authorised agencies approved by GoI. In this connection the Authority pointed out that the Authority has already resolved during the last meeting held on 06.05.2009 to authorize the Member Secretary, Tamil Nadu State Coastal Zone Management Authority (TNSCZMA) to conduct the HTL survey along with a study for finding out the presence of salinity level, as per CRZ Notification 1991, in the Buckingham canal from Adyar to Muttukadu instead of taking decisions on selected project sites by engaging Institute of Remote Sensing, Anna University, an authorized agency approved by GoI. Accordingly the work has been entrusted to IRS, Anna University and as per the report furnished by IRS, there is no tidal influence along the Buckingham canal from the mouth of Buckingham canal at Kotturpuram to Solinganallur.

Hence the Authority resolved to request the Member Secretary, Tamil Nadu State Coastal Zone Management Authority to send the proposal to Ministry of Environment and Forests, Government of India and obtain approval for the deletion of the above said areas falling between Kotturpuram and Solinganallur along the Buckingham canal from CRZ.

The Authority further resolved that non-applicability of CRZ Notification 1991, in respect of the above project, will be issued on receipt of necessary orders from Ministry of Environment and Forests, Government of India as stated above.

AGENDA ITEM NO:6 Construction of Elevated Express Way from Chennai Port to Madhuravoyal proposed by M/s. Chennai Port Trust

M/s. Chennai Port Trust has indicated that some portion of the Elevated Express Way will fall in between LTL & HTL to avoid conflict with the existing roads and the alignments of the railway lines and also to avoid substantial acquisition of land and dismantling of major commercial and residential buildings constructed already along the existing roads. They further informed that the Elevated Corridor will run at a height of 7 mts above the level of the existing banks of the Cooum river and will be constructed on pillars which occupy comparatively less space on the banks and hence the environmental impact due to construction of the Elevated road on pillars in the inter tidal zone is not comparable to that of construction at the ground level.

In view of the above facts, the Authority resolved to recommend the proposed constructions in the inter-tidal zone (between LTL and HTL) subject to the following conditions as already resolved in the 49th meeting held on 12 01 2009.

- 1) The constructions should be located in such a way that they should not affect the hydraulic free flow of water in the Cooum river.
- 2) There should not be any extraction of ground water in CRZ.
- 3) No blasting activities in CRZ is permissible.
